The inspection started on 22 October 2014 at 3 PM. It ended on 24 October 2014, at 4.30 PM.

Before starting the inspection, Ms Hirsch-Ziembinska explained the inspection procedure and the purpose of inspecting Frontex's file. She drew attention to the fact that the public have no access to confidential documents obtained by the Ombudsman's services during an inspection. She requested the representative of Frontex to indicate those documents which Frontex considered as being confidential.

Subsequently Ms Hirsch-Ziembinska carried out an inspection of the files presented to her.

Ms Hirsch-Ziembinska obtained copies of the documents which are listed above **and underlined**. Frontex informed Ms Hirsch-Ziembinska that the underlined documents are all confidential. In accordance with Articles 5.2, 13.2 and 14.2 of the Implementing Provisions of the European Ombudsman, **the Ombudsman's inspection will not result in any other person obtaining** access to **these** documents.

In reply to the questions put by Ms Hirsch-Ziembinska, Frontex' representatives clarified the following issues concerning the inspected documents:

(I) In 2014, as of the day of inspection, there were 32 joint return operations of which 53% had no monitors physically present on board during the flight.



(II) The planning and evaluation meetings of national focal points take place four times per year and during two of them the European Commission is present; normally all Member States take part.

(III) The JROs procedure includes the following steps: (a) the JRO offer is first submitted to Frontex by the Organising Member State (OMS); (b) Frontex acknowledges the offer in a subsequent letter to which it attaches "Conditions for the JRO"; (c) an Implementation Plan - annex to the Specific Financing Decision- is prepared by Frontex in cooperation with the OMS and is sent to the Participating Member States (PMS) in advance of the JRO; (d) within 14 days after the end of the JRO, the OMS provides Frontex with a standardised Final Return Operation Report; (e) Specific Financing is issued before the JRO and addressed to the OMS and each PMS: (f) Frontex drafts the Evaluation Report (the Fundamental Rights Officer puts her initials); (g) debriefing forms are drafted by the escort leaders from the OMS and PMSs; and (h) Frontex makes the final payment after having received the Final Financial Statements.

(IV) As regards CJROs: This is a new category of JROs. It was introduced at the end of 2013. In these operations, the third country to which immigrants are returned provides the plane, escorts and medical staff for the operation. The payment to the third country for these expenses is made by Frontex via the OMS. The handing over of immigrants by national authorities/escorts takes however place in one of the EU airports. Frontex gives training to escorts of the third country. The CJROs are possible under the following conditions: (a) the third country must be a party to the European Convention on Human Rights; (b) a minimum of one monitor, one representative of Frontex and one representative from the OMS must be present on board during the return flight; (c) escorts from the third country present in the CJRO should have been trained by Frontex beforehand. Frontex is now working on the handbook for the CJROs. Legal aspects of the CJRO are to be discussed by the LEG-NET (Legal network of national authorities).
