- [1] Following the Member of European Parliament's financial declaration template, any regular income received in respect of each item declared shall be placed in one of the following categories:
- 1. EUR 500 to EUR 1000 a month;
- 2. EUR 1001 to EUR 5000 a month;
- 3. EUR 5001 to EUR 10 000 a month;
- 4. more than EUR 10 000 a month.

Any other income receivde in respect of each item declared shall be calculated on an annual basis, divided by twelve and placed in one of the above categories.

If the amount of the regular or other income is below the threshold of category 1, i.e. below 500 EUR per month, or if the declared occupation, membership, activity, holding or partnership is not remunerated, a category does not need to be indicated.
