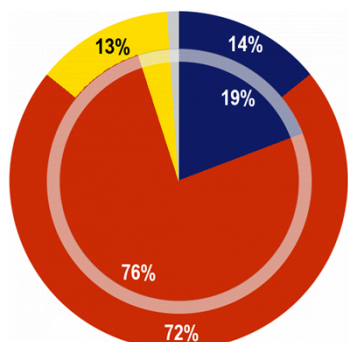

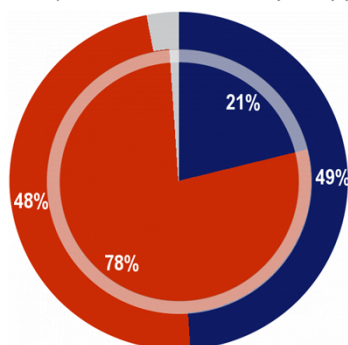

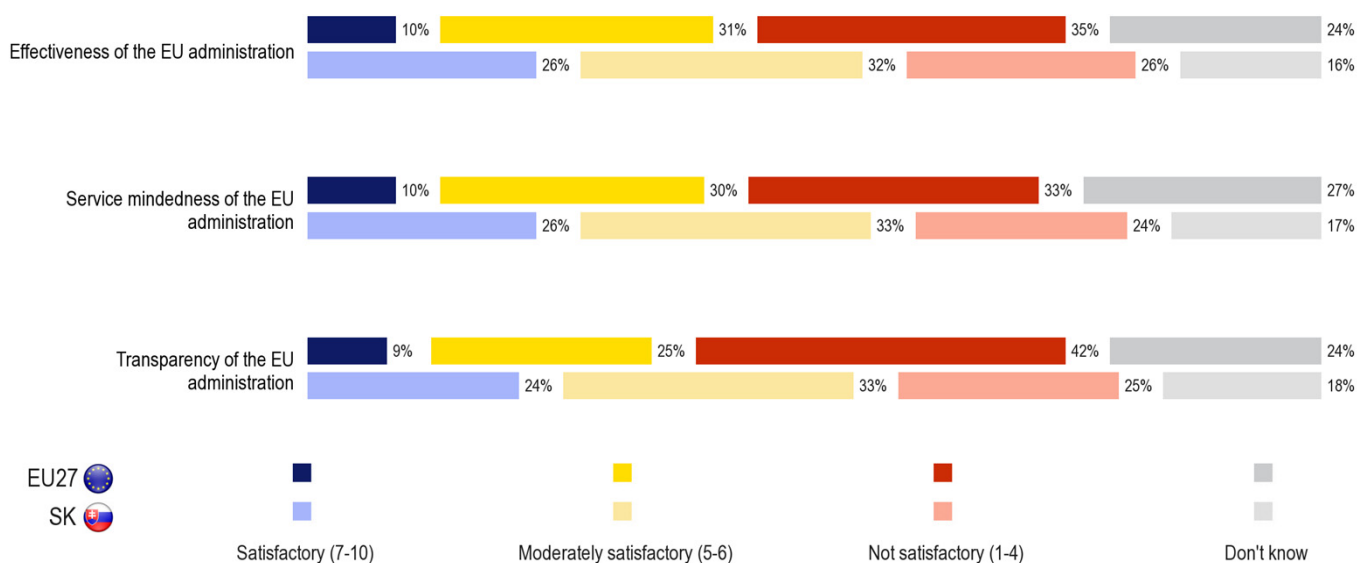

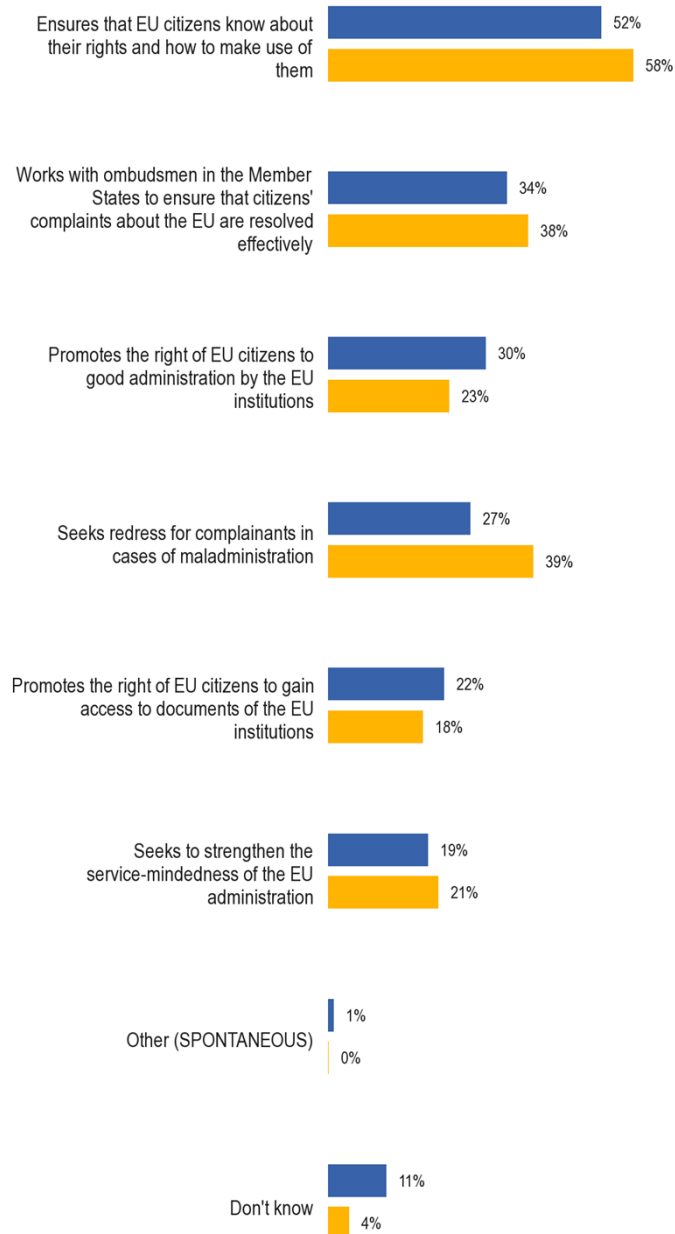

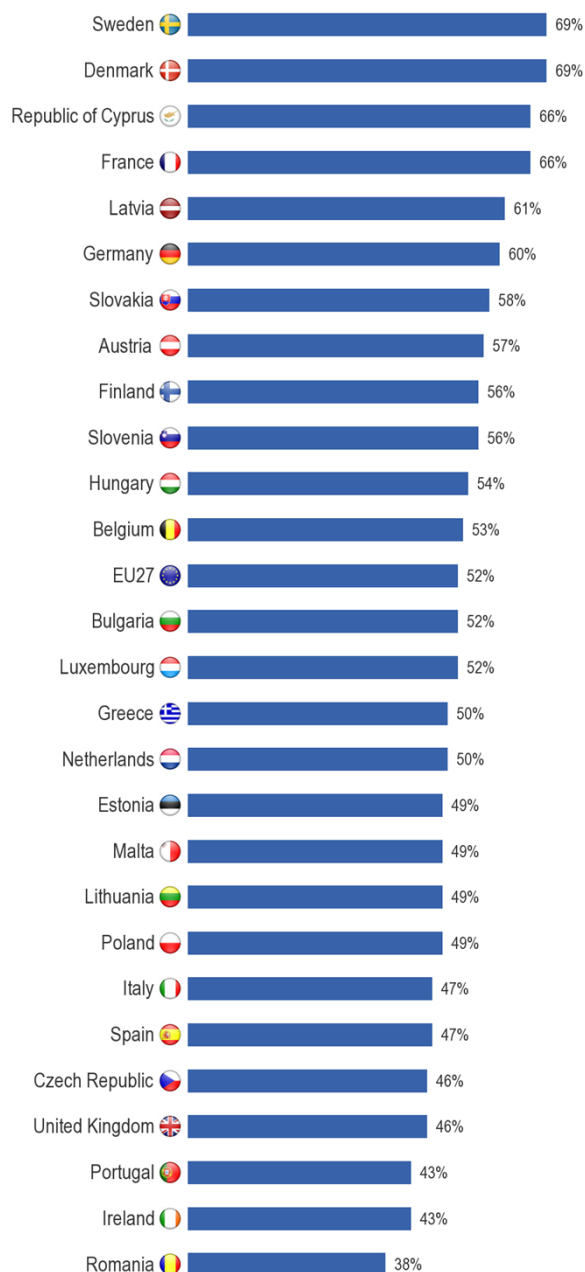
## The responsibilities of the Ombudsman

QB3. According to you, which of the following responsibilities of the European Ombudsman are the most important?



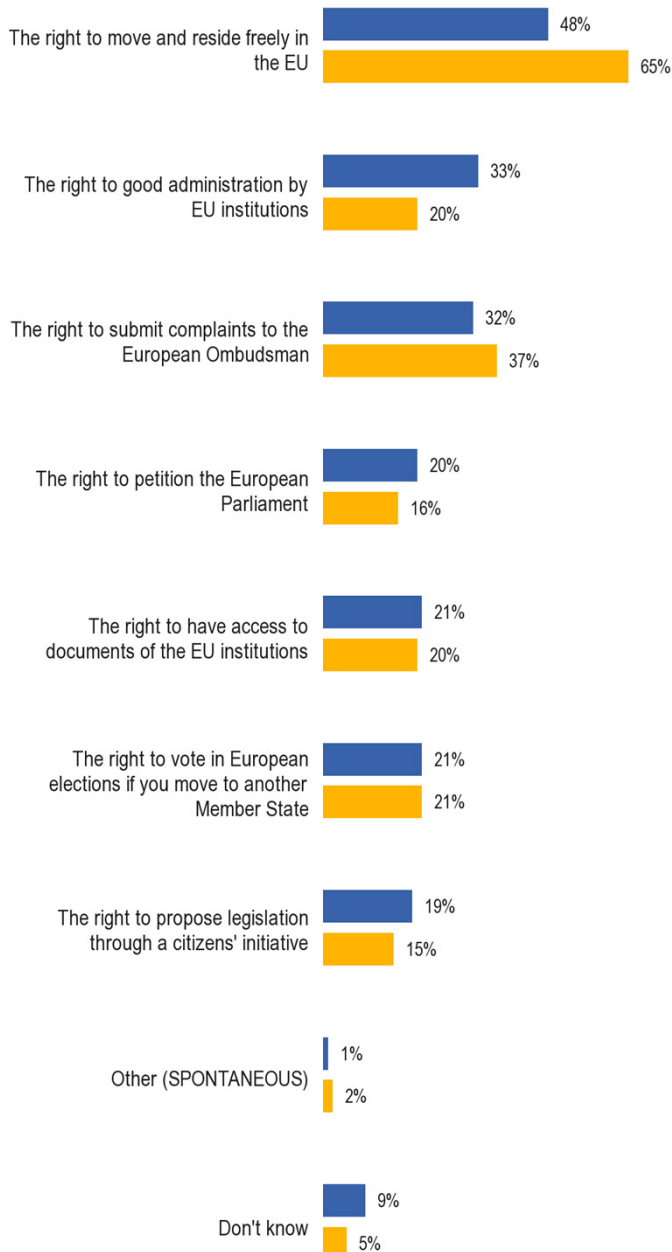
Question: QB3. According to you, which of the following responsibilities of the European Ombudsman are the most important?
